To determine the cost of a suppression permit under \$1,010.00, you need to combine the base fee, cost of plan review, and the .50 **state surcharge**. On valuations over \$1,010.00, the first \$1,010.00 is .50 and any additional amount is to be multiplied at the rate of .0005 per every \$1.00.

Formula: Base Fee + Plan review + Surcharge = Permit Cost

Table 1 - The **base fee** (see Table 1) is determined by the total valuation (labor & materials) of the job.

Total Valuation	Base Fee
\$1.00 to \$500.00	\$23.50
\$501.00 to \$2,000.00	\$23.50 for the first \$500.00 plus \$3.05 for each additional \$100.00, or fraction thereof, to and including \$2,000.00
\$2,001.00 to \$25,000.00	\$69.25 for the first \$2,000.00 plus \$14.00 for each additional \$1,000.00, or fraction thereof, to and including \$25,000.00
\$25,001.00 to \$50,000.00	\$391.75 for the first \$25,000.00 plus \$10.10 for each additional \$1,000.00, or fraction thereof, to and including \$50,000.00
\$50,001.00 to \$100,000.00	\$643.75 for the first \$50,000.00 plus \$7.00 for each additional \$1,000.00, or fraction thereof, to and including \$100,000.00
\$100,001.00 to \$500,000.00	\$993.75 for the first \$100,000.00 plus \$5.60 for each additional \$1,000.00, or fraction thereof, to and including \$500,000.00
\$500,001.00 to \$1,000,000.00	\$3233.75 for the first \$500,000.00 plus \$4.75 for each additional \$1,000.00, or fraction thereof, to and including \$1,000,000.00
\$1,000,001.00 and up	\$5,608.75 for the first \$1,000,000.00 plus \$3.65 for each additional \$1,000.00, or fraction thereof

The Plan Review Fee is 65% of the base fee when conducted by a city of Maple Grove Fire Inspector.

Included in this cost is the review of one (1) sprinkler drawing, one (1) hydraulic calculation analysis, one product submittal, and the report. If the plans are returned as rejected, or revised and resubmitted, the plan review fee for the second or subsequent reviews is NOT included in the initial plan review fee. For resubmitted plans, the cost of plan review is an additional \$47.00 per hour.

Minimum scale 1/8"=1'-0"

Maximum sheet size is 30" x 42"

The Following Fees apply if the plan review is sent to an outside consultant:

Fire Sprinkler Plan Review - First Sheet: \$300.00

Each Additional Sheet for the Same Project: \$150.00

The cost of resubmitted plans is \$150.00 per sheet.

As an example, if there were three sheets the fee for the initial plan review and report would be \$600.00. Subsequent reviews of revised drawings for the same project would be \$450.00 for each review, based on the three drawings.
